The Walla Walla Police Foundation creates partnerships to provide resources and programs that help the Walla Walla Police Department perform at the highest level of service for the citizens and businesses of Walla Walla. We believe that investing in community and building relationships with those we serve is the most effective means of promoting public safety.

Although K9 Officer Farel's figurative shoes will be hard to fill, his position is of great importance to the security and safety of those that call Walla Walla home. In anticipation of Farel's retirement, the Walla Walla Police Foundation successfully raised over \$20,000 to cover costs associated with obtaining a new apprehension K9. These costs include the purchase of the K9 officer and travel and training for the K9 officer and K9 handler, K9 medical costs, supplies and equipment needed.

The Walla Walla Police Foundation has established a Community Care Fund to provide emergency financial assistance to community members in need. Community members in need could include victims of crimes such as domestic violence or human trafficking, or someone that just needs a handup, a hotel room for the night, or a tank of gas to get out of town to escape an abusive relationship. WWPDP Officers in years past have routinely reached into their own pockets to help those in need.

The Walla Walla Police Foundation now provides discretionary funds to assist these community members in emergency situations. In 2021 the Foundation granted a total of \$2,650 to replenish the petty cash fund held

at the Walla Walla Police Department to reimburse officers for these community care expenditures.

The Foundation spent \$1,479 in Community Care Funds to purchase items to be included in special needs boxes for community members in need. The boxes were based on age and size. They included many basic supplies such as socks, underwear, shaving supplies, personal hygiene items, tooth brushes, soap, shampoo, pillows and blankets, etc. One of our Community Partners generally provided purchase discounts and our volunteers, including many of our police officers, spent a lot of time gathering and assembling these items for distribution.

The Foundation project in May was for a family at a home on Union Street. It is the home of four children and their working mother where the father had recently passed away. The house was not very livable inside or outside. We used \$341 of funds and significant number of volunteer hours. Our volunteers removed weeds, trimmed vegetation, and hauled junk, including vehicles, from the yard. Inside the house our volunteers cleaned and hauled off unusable items. One of our Community Partners generously donated a new couch, table and chairs etc. for this needy family.
